HIGHLIGHT ON SECRETARY'S VIEW ...



Regardless of what consequences are to stand ahead, Abhoy Mission, tireless, fearless and boundless, is going forward step by step with its diversified acts keeping the betterment of mankind in view. We know, the done works are good but the undone are better.

In accordance with the United Nations Principles for Older Persons life and National Policy on Older Persons formulated by the Govt. of India; wherein provision of maintaining standard of living with all required elements; have been kept. But, owing to the Directive Principle of State Policy & as per provisions of the

NPOP; the State shall implement the Policy within its economic capacity. For this reason, the facilities and opportunities cannot be provided to the elderly people of all the States in uniform way. Hence, the basic needs for facilities & opportunities of the elderly viz. Old Age Pension should be uniform all over the country and it should be enhanced time to time in accordance with the price index. For example, the amount of monthly Old Age Pension is Rs.2,000/- in Goa, in Tripura it is Rs.500/-. As the steady rise of elderly persons is going on, the provisions for infrastructural facilities has not been prepared upto the desired level for the elderly for passing their livelihood with minimum needs.

In order to hold high up the vision "Making rights real- an approach to inclusion", we are very carefully and deeply fabricating an acute design for the welfare and betterment of the PwDs in course of carrying out our mission.

As per provisions under the RCI Act, Persons With Disability Act (PWD), National Trust Act, Right to Education Act etc; the welfare & charity approach is already shifted to rights based approach; but it is observed that education and training are obviously necessary to bring the PWDs in common platform. Whereas, there is lacuna in creating required infrastructure and manpower viz. lack of educational facilities, shortage of trained & sensitive teacher, barrier-free environment & barrier-free school, inadequate vocational training, lack of appropriate assistive devices, shortage of coverage in rehabilitation services. To implement the Right to Education for persons with disabilities properly, we are lagging far behind as a North-Eastern State. It is a matter of repent to say that variation is noticed among the disabled with various categories in payment of Disability Pension in our State; this variation to be removed to bring in a uniform system.

The Abhoy Mission is still working with dedication and determination. In the last financial year, we have engaged ourselves in a lot of activities. As a recognized Organization of RCI, Abhoy Mission is conducting work force development programme in the field of disability through Foundation Course, B.Ed. (Special) and Post-Graduate Professional Diploma Course under different Universities. We develop caregiver under the guidance of National Trust, Govt. of India. In the field of geriatric care, we conduct work force development programme as authorized by the National Institute of Social Defence, Govt. of India, New Delhi. Success in attracting small & tiny contributions from very common people will provide a Himalayan forward thrust in the activities of our Organisation for disadvantaged section of the society including disabled and elderly group of people.

Give India, Mumbai have stretched forth their benevolent hands by colleting fund from across the globe and sending us strong financial support with other necessary amenities to upgrade the condition of Vulnerable aged Senior Citizens and PwDs. Thus, we convey our best gratitude and magnanimous feelings to them.



Annual Report 2013-14, Abhoy Mission Brief Introduction of the Projects / Programmes 'Abhoy Ashram' - Rehabilitation Centre for Senior Citizen (Old Age Home)

The size of elderly population is increasing day by day. Share of elderly population increased from 5.6% in1961 to 6.7% in 1991 and then to 7.4% in 2001. The older people are seldomly given proper care, as family members remain busy otherwise. A Rehabilitation Centre (Old Age Home) was set up by Abhoy Mission in the year 1993 to restore physical, psychological and social well being in older persons having no means of livelihood and left careless and shelter less in the society. Inmates coming from all over the State are being looked after here round the clock by a specially trained staff. Of the present 25 inmates, 90% are suffering from ageing related disabilities.

Community Based Rehabilitation under SaGP project, Help Age India

Old Age dependency ratio is increasing gradually day by day. The ratio increased from 11.5% in 1971 to 13.1% in 2001. In rural areas the figure exceeds 14% in 2001. From 2003, Abhoy Mission, with support of Help Age India through 'Sponsor a Grand Parent'(SaGP) programme, started providing need based help to old age people to live within their families with dignity in three rural areas of erstwhile West Tripura District. Based on consultation and requirement of beneficiaries, food grains, clothes, garments, mosquito nets, pocket money etc. are provided to 50 aged grandparents.

Community-based Rehabilitation of Senior Citizens from Support of Give India :

The Give India is a donation platform for providing noble Support throughout the country through extending their helping hands in concerned deserving fields of welfare. As a recognition of our welfare services, the Give India have come forward to raise our head to a uplifted position by providing support for the targeted groups of Abhoy Mission, which is considered by us as a new feather in the cap of Abhoy Mission. Through Abhoy Mission, Give India is providing generous supports for two sections of people – Elderly people and Children with special needs, for which we convey our best gratitude to the Give India.



Support to Elderly people

Ration and toiletries @ Rs. 530/- per beneficiary per month are provided to elderly people from the noble assistance of the Give India as a measure of raising of their standard of living and to save them from the feeling as a burden of the family. Allowance @ Rs. 100/- for medical expenses is included in this support, which is provided to the beneficiaries keeping emphasis to rural areas. The community based support, which is being provided to elderly people helped to restore psychological and social well being in them to some extent. All these services are provided through community distribution in different places.

Help Line and Counseling Centre: -

In order to provide Help Line round the clock to those people and their relatives who are facing inconveniences due to some communication gap with the children or nearest ones. At times, such information gap leads to domestic violence with senior citizens and many other unforeseen situations such as: serious illness, despair due to loneliness, uncalled for awkward interactions leading to violence within the family etc. In such cases, they can make telephonic communication at any moment with us using 0381-21338607, 919436123069 phone numbers, or e-mail – <u>abhoymission@rediffmail.com</u>. In case of security question, we provide them Doctor, Physiotherapist, care giver, food, health, protection and necessary aid wherever necessary including Ambulance Facilities. Counseling and advocacy on behalf of the client within the family and community is also taken up wherever necessary including police, assistance etc. to demonstrate a peaceful atmosphere devoid of domestic violence.

Training Programmes on Geriatric Care/ Care for Elderly under National Institute of Social Defence.

The gradual increase of elderly population is global concern nowadays. It is the need of the hour to ensure care for this section of people. The National Institute of Social Defence, in 2005, ascribed the liability of conducting training course for the younger generation who are equipped through training to attend the care & needs of older persons.

Six months Certificate Course in Geriatric Care

The course was conducted from 30th March, 2013 to 29th September, 2013. 30 young persons including 24 ladies attended the programme. Placement of most of the trained persons was possible in different Nursing Homes, Home Based Care, and Nursing.

One-day sensitization for Empowerment of Elderly.

One- day sensitization programme for Panchayat Raj functionaries on Empowerment of Elderly was organized at Belonia Nagar Panchayat Samiti Hall on 8th June, 2013. The Chairperson, Belonia Nagar Panchayat inaugurated the programme. Number of Gram Pradhans, community members and other concerned officials participated in the programme.

One- day Media Sensitization programme on Ageing Care.

One-day sensitization programme on role of Media covering the issues of Geriatric problems & Care, Social neglect and disrespect to senior citizens was held at DTGP Conference Hall, Udaipur, Gomati District. A number of media persons from different Newspapers & Electronic Media /News Channels attended the programme. The programme was inaugurated by the Zila Sabhadipati, Gomati District, Sri Himangshu Roy and Susmita De, Secretary, Abhoy Mission in presence of concerned functionaries of Social Welfare & Social Education Department.

One-day sensitization programme for school teachers

With focus on Maintenance & Welfare of Parents and Senior Citizens was organized during the year under report at Swabalamban, A.D.Nagar, Agartala on 15th September, 2013. In the said programme, thread-bare discussion on International and National Policy was done. As many as 40 school teachers from all parts of Tripura State participated in the programme.

After lunch hour of the programme, an open discussion was arranged in which more than 90% of the participants opined that a common policy be introduced in all the States of the country. Besides, they suggested that the financial implication for the purpose be revised and enhanced keeping parity with the price index.

Two days' State Level Consultative Meet on Ageing Care issues for Government Officials/NGOs

Two days' State Level Consultative Meet on Ageing Care issues for Government Officials/NGOs with special focus on Maintenance and Welfare of parents and Senior Citizens Act, 2007 was organized at Sunity Conference Hall, Ramnagar, Agartala on 28th & 29th October, 2013. Hon'ble Vice-Chairperson, Tripura Women Commission set the consultative meet on its orbit by lighting the candle. Smt. Bijita Nath, Hon'ble Minister for Social Welfare & Social Education attended the meet as Chief Guest. Member-Secretary of the State Legal Services, Director of Social Welfare & Social Education & Lecturer of Tripura Nursing College were present as Guests of honour. Government officials of state and Central Government Departments, school teachers, NGO representatives participated in the programme.

Five days' training programme on capacity building of key functionaries of NGOs in Geriatric Counseling

This programme was organized in Agartala from 26th to 30th December, 2013 in total 35 functionaries from 34 Organizations attended in the inaugural programme. The inaugural programme was presided by Sri Shyamal Deb, President of Abhoy Mission. Mrs. Sucharita Debnath, Ms. Supriya De, Mrs. Debi Chakraborty & Mr. Debarshi Deb acted as resource person in the training programme.

Community Training programme in Computers for Senior Citizens

Community based training in Computer for senior citizens for twenty days was organized at Ramnagar, Agartala. The resource person for the programme was Sri Anuruddha Chakraborty. He was assisted by Sri Debarshi Deb. 20 numbers of qualified senior citizens including two women took part in the training programme. Counseling & liaisoning issues with audio-visual system were integral part of the programme.

One month Certificate Course on Basic Issues of Geriatric Care

30 key persons from the NGOs who were working in the field of Ageing Care, functionaries of Old Age Home and elderly related programmes attended in the programme.

'Swabalamban' Special School for children with M.R. & Multiple Disabilities

The pioneer special school for mentally retarded children in Tripura, 'Swabalamban' started its journey on 26th January, 1991 with only 5 students, in association with some parents and then



converted to residential-cum-Day schoolar special school for Mentally Retarded children and children with multiple disabilities. The school is located under Gokulnagar G.P., Sipahijala District from the year 2000. At present 60 students-30 residential and 30 non-residential are attending the Special School. The School is supported under DDRS scheme under the Ministry Social Justice of & Empowerment, Govt. of India from 30th March, 2014. On request & pressure of parents of urban students, the management was compelled to transfer a part

of school with urban students to the Head Office Complex from 30th March, 2014, as the parents find difficulties to bring their children to Gokulnagar despite receiving negligible amount of transport allowance and lack of own transportation facilities in the School.

Academic skill development training, training in activities of daily living, facilities of physiotherapy & occupational therapy, skill development in sports & games, training in Arts, Music & Dance, prevocational training and recreational facilities are provided in the School.



Swabalamban Care & Protection on Deafblind programme

Early intervention, identification, assessment, health care facilities, physiotherapy, occupational therapy, vocational training are provided to Deafblind children with effective technical support from Sense International (India) and financial support from Give India. The programme was actually started in 2006 with support from Sense International (India) and thereafter the programme has been running with technical support only.

- In total, there are 11 beneficiaries in the programme.
- Vocational training is provided to 04 beneficiaries with Deafblindness.
- Early identification and intervention are the essential part of the programme.
- Awareness programme for community are being organized on regular basis.
- Parents are being actively involved in the programme.

A. <u>Support to Children with special needs under Give India</u>

Support is provided in two ways-

- Food, medical care and toiletries are provided. In the year 2013-14, in total, 27 number of children with special needs were benefitted through this support.
- Home based skill training to children with multiple disabilities of 02 to 18 years age. In total, 16 children with multiple disabilities were benefitted through this support in the year 2013-14.



Children home for Orphan with special needs

As per guideline of Integrated Child Protection Scheme(ICPS) UNDER Ministry of Women and Child Development ,Govt. of India, Abhoy Mission is running a children home under the nomenclature 'Swabalmban Rehabilitation Centre' for the orphan children with special needs and street children or the children whose parents are unable to maintain them. The home is registered with the Government of Tripura, Directorate of Social Welfare & Social Education vide Registration No.03/13 under Juvenile Justice Act, 2000 as well as registered with PWD Act. Girls within the age range of 0-18



years and boys below 10years are admitted in the home. Total seat capacity is 40 for Girls and 10 for boys. Number of children in each quarter in the year 2013-14 are as such-

Barrier free environment, homely & friendly atmosphere is being provided at children home. The service to the children is provided through assessment, education programme, health care, fooding & lodging, 24 hours nursing facilities, training on independent living skills, prevocational training, physiotherapy, recreation facility are provided on regular basis. To restore visual acuity in Mampi Das, a Deafblind girl, cornea transplantation was done in her right eye on 6th May, 2013.

The children are provided to take part in different festivals, in different spiritual and social programme. The children of the home took part in State Game, District Game of Special Olympic in the year 2013-14.

Programme on Disability issues covering the National Trust Act, 1999

Sensitization and awareness programme were conducted throughout the year involving SSA

Govt. school teachers and teachers. community people of Tripura State. In accordance of awareness and sensitization programme, different Banks and Accountant General Office at Agartala are referring individuals with disabilities to the office of Abhoy Mission for Legal Guardianship



certificate. throughout the year numbers of applications for Legal Guardianship were forwarded to the District Magistrate and Collectors after careful checking, scrutiny and physical enquiry. Number of applications for Niramoy Health Insurance were collected and forwarded to appropriate authority, New Delhi.

Prime Minister's Skill Development Programme

In pursuance of the national call of the Hon'ble Prime Minister of India, National Institute for

Empowerment of Persons with Multiple Disabilities (NIEPMD), Chennai give us the opportunity for economic development of multiple disabled persons. Under the programme, Skill Development Training on measurement, cutting, tailoring, stitching and embroidery was conducted during the year under report for 20 nos. of Multiple Disabled persons in collaboration with our Organisation for the first time in the State of Tripura. Staff salary & raw materials for the programme were provided by the NIEPMD and supervision & monitoring were done by our Organisation. After completion of



the programme, Certificates were given to them by the Director, NIEPMD. Out of above 20 trainees, 06 trained persons have become able to rehabilitate themselves individually and the remaining person rehabilitated themselves in group.

Annual Report 2013-14, Abhoy Mission Sixth North Eastern Regional Parents' Meet

Abhoy Mission organized Sixth North Eastern Regional Parents Meet in association with PARIVAAR, Bangalore on 8th & 9th February, 2014 at Saheed Bhagat Singh Youth Agartala. The programme Hostel, was sponsored by the National Institute for Mentally Handicapped, Ministry of Social Justice & Empowerment, Govt. of India. PARIVAAR is the National level organization recognized by Ministry of Social Justice & Empowerment, Govt. of India consisting of Parents' bodies with membership of 230 Associations. The programme was inaugurated on 8th February, 2014 by Lt. Col.(Retired)V.K. Gautam, President, PARIVAAR in presence of various officials of PARIVAR of different



States. The children of Swabalamban Special School presented their performance through songs, dances etc. in the inaugural programme. The theme of the Meet was 'Making Rights Real! An Approach to Inclusion'. 196 members of parents of the children with special needs from all the Districts of Tripura and from the other States of North Eastern Region participated in the programme.

Annual Report 2013-14, Abhoy Mission Sahayogi Care Giver Training under National Trust

Abhoy Mission is conducting Sahyogi Care Giver Training Course under National Trust, Government of India since 2009, 26 numbers of trainees including 22 ladies imparted training in the year 2013-14. On theoretical part, the training programme covered – Introduction of Disabilities, types and degree of disabilities, causes of disabilities, needs of persons with disabilities like cerebral palsy, mental retardation, autism, blindness, low vision, ADHD and multiple disabilities. Practical aspect of training covered functional assessment of children with disabilities, management and care of different disabilities, management of prolonged bed-lying condition.



PROGRAMMES CONDUCTED DURING 2013-14 IN COLLABORATION WITH NIMH :

Abhoy Mission organized the following programmes for the Mentally Handicapped children/persons during the year 2013-14 in collaboration with National Institute for the Mentally Handicapped (NIMH), Govt. of India:

SPECIAL OLYMPICS BHARAT, TRIPURA CHAPTER :



Special Olympics International is a Global Organisation which is working for the development of sports for the Intellectually Disabled Athletes. Special Olympics Bharat is the National Confederation in India which is the Nodal Agency of Ministry of Youth Affairs and Sports, Govt. of India for arranging games and sports for the Intellectually Disabled Athletes. Special Olympics Bharat - Tripura Chapter under Abhoy Mission is the branch of Special Olympics Bharat in Tripura State. As a part of the initiatives of the Healthy Athlete Programme, OPENING **EYES PROGRAMME** was organised at

Indira Gandhi Memorial Hospital Complex with cooperation of National Programme for Control of Blindness, Agartala for 2 days w.e.f. 9th to 10th April, 2013. Participation.

As many as 196 Nos. of Special need children Athletes participated to avail the opportunity of having vision test in the programme. Dr. S.K. Dhar, Vice Governor Elect. North East India, Lions Club International, Prof. Anirban Dey, Clinical Director, Special Olympics International, Sri Shyamal Deb, Area Director, SOB-Tripura were present in the inaugural Programme. Besides them, Dr. Batakrishna Paul, Eye Specialist conducted the Vision Test of the Athletes on 9th & 10th April. Dr. Pranabendu Barman, Eye Specialist conducted the Vision Test of the Athletes. During the test, 2 nos. of athletes were identified for Cornea Transplantation. Accordingly, Smt. Mampi Das who was Registered Athlete of SOB, Tripura Chapter was selected for her Cornea Transplantation and Operation was done successfully. Now She has become capable to see with her eyes as other children having normal eye-sight.

Apart from the above, the SOB – Tripura Chapter conducted Sports & Games for the Intellectually Disabled Athletes to show and prove their capability that they are not lagging behind in this field from the normal children.

Advance Coaches Training Programme was conducted by the Special Olympics Bharat – Tripura Chapter at Acharya Prafulla Roy Memorial H/S School Field, Kunajaban, Agartala w.e.f. 4th to 8th August, 2013. The disciplines were Athletics, Bocce and Handball.

Community Coaches Training was organized by the Special Olympics Bharat -Tripura Chapter on 8th & 9th March, 2014 at Kamalpur Boy's H.S School Stadium, Kamalpur, Dhalai District, Tripura for 50 nos. of Trainees and on 18th & 19th March, 2014 at Sanghadip Training Institute, Dharmanagar, North Tripura District for 50 nos. of Trainees. In the opening, Sri Shyamal Deb, Area Director, Special Olympics Bharat – Tripura put a prolong discussion regarding the objective and the need of the training of the Community Coaches. The Training Programme was conducted by a team of Master Trainers and Technical Persons



headed by Smt. Kanta Deb Sarkar, Research Scholar, NIS, M.Phil, M.Ed.

Special Olympics Bharat has been using sports as a platform for development of athletes with Intellectual Disabilities – offering a range of service to them to help in their physical growth and personality development, enhancing their confidence and self esteem. It is realized that a very significant need is missing from all the interventions that have been planned for them – and that is the need to train young athletes on sexual and reproductive health and behaviour. This intervention is critical in a country like India where everyday it is heard that the girls are being abused in various ways specially girls with Intellectual Disabilities. This is not come to light as such girls are unable to express the matter sometime. Therefore, the girls and women with intellectual disabilities need

more education on the subject than others. Focused training in this direction would equip the girls with the right awareness to help them identify and address exploitation as they travel, live, work and play. The ultimate goal of the Community Coaches Training is to make the Physical Instructors conversant with the above matter and handle the girls' athletes with Intellectual Disabilities with care.



Family Service Programme



Early Intervention

As a measure of early intervention, we maintain close liaison with Hospitals, Nursing Workers, Homes. ASHA Multipurpose Workers, Care Givers, Aayas etc. who are main source of our information provider. We conduct awareness programme with the above functionaries how to identify abnormal symptoms with the newly born child from the Accordingly, we advice the time of birth. parents to provide support to their babies as per need of the child. Parents are also advised to take their babies with motor difficulties to the

Physiotherapists or Occupational Therapists. Parents of children with speech problem

are advised to take advice of Speech Therapists and to touch with the Special Teacher. We also arrange trained caregivers who provide support to the children with disabilities and their families through home based service.

School Readiness Programme

The parents are advised to send their children with disabilities to Anganwadi Centre or Nursery school or in Special school to facilitate them readiness for main stream. Care Givers deployed by our organization also prepare children with disabilities for regular schooling.

Counselling



Prior to starting of Counseling programme, the parents of children with special need, the Allmighty has vested the responsibility to born & brought up the children as an outstanding person identified by the God. Accordingly, the parents should keep and maintain strong patience to give trial to their children to make them capable to do personal works viz. toileting, brushing, bathing, roaming, proper sitting, walking practice, dressing, mode to handle water glass, to take food, identification of colour, taste, scent, fruits & vegetables, coin & rupee etc. which should be kept in continuous process. In any circumstances, these works of the child should not be done by the parents; if it is done so; these children will be severe burden of the family as well as for the

society. Not only that such children should not be kept inside the screen and they should be taken outside in different programme as are done for the normal children.
