# Rehabilitation Centre for Senior Citizen (Old Age Home)- 'Abhoy Ashram'

A Rehabilitation Centre for Senior Citizen, namely "Abhoy Ashram", was set up in the year 1993 to make available round the clock care for them by the trained &

skillful service providers. Beneficiaries are being admitted in the centre with recommendation of Social Welfare & Social Education Department, District Legal Services Authority & Police.

Reinstatement of happiness and well-feeling in senior citizens, who have basically no shelter & caretaker, from physical, psychological and social point of view is the focus area of the program.


# **Community Based Rehabilitation to Senior Citizens**

Restoration of psychological and social well being in elderly people in rural areas through support in the sector of nutrition, health, hygiene and encouraging freedom is the primary objective of the program.

Ration & toiletries @ Rs. 530/-, per month are provided to elderly people with dignified assistance of Give India as a of measure of raising standard of living and removal of feeling of considering self as burden in the family. Allowance @ Rs.100/- for medical expenses is included in this report. Support provided to number of elderly people in different months has been shown in Fig 1

Facilitating the countryside senior citizens to survive with esteem within their families is the most important purpose of the program. base on consultation and

requirement of beneficiaries, food grains, clothes, garments, mosquito nets, pocket money etc. are provided to 50 aged parents.

# Swabalamban Special School for Children with Multiple and Intellectual Disabilities

The earliest special school for children with intellectual disabilities in Tripura, the 'Swabalamban' commenced its voyage on 26<sup>th</sup> January, 1991 with only 05 students. More than sixty students are taking education in this school. The school is positioned in Gakulnagar Gram Panchayat under Sepahijala District.

The aim of the program is schooling to children with multiple and intellectual disabilities through addressing their individual differences.


Education involves individual education program and monitoring system by means of adapted apparatus and resources.

# <u>Community Based Rehabilitation for children with disabilities through</u> <u>support from Give India</u>

Proficiency training in dwelling places and nutritional support are being provided to children with multiple disabilities. In total, 778 children with multiple disabilities including girls were benefitted through this support in the year 2017-18. # Swabalamban Rehabilitation Centre for Orphan Children with Special needs

Signified by code of Integrated Child Protection Scheme (ICPS) under Ministry of Women and Child Development, Govt. of India, Abhoy Mission is operating a Child Care Institution under the nomenclature of 'Swabalamban Rehabilitation Centre for orphan children with special needs'. The Home is registered with the Government of Tripura, Directorate of Social welfare & Social Education vide Registration No.03 under Juvenile Justice Act, 2015.

# **Objective-**

- Structuring caring & protective environment for orphan children with special needs in difficult circumstances
- Instituting vital services
- Promotion of measures to avoid harm
- Services by skillful & qualified professional

Girls within the age range of 0-18years and boys below 10 years are admitted in home. Total seat capacity is 30 for girls and 20 for boys. By the end of 2017-18 there were 47 enrolled children in the Rehabilitation Centre.




Fig 3. Number of enrolled children with special needs in Rehabilitation Centre in 2017-18.

### SUCCESS STORY



Maser Madhu Sabdakar & Master Swapan Sabdakar got back right to stay in their family

On 15<sup>th</sup> July, 2017 at 11:30 pm, two siblings Madhu Sabdakar aged 7 yrs and Swapan Sabdakar aged 4 yrs, were enrolled in our Swabalamban Rehabilitation Centre for Children with Special Needs complying with the order issued on same date, by the Chairperson, Child Welfare Committee, Dhalai District of Tripura. Both children were sons of Paban Sabdakar and Minakshi Sabdakar of village Ghantachhara, P.O. Kulai Bazar, Dhalai District. In GD Entry No. 25 dated 15.07.17 O/C, the Officer in Charge of Kamalpur P.S. stated that the said two minor boys were found wandering near Kamalpur College main entrance gate along with their father. The mother of the two children left family few days back and it was learnt by the police through enquiry that their father was not mentally stable.

After the enrolment, we noticed the shades of fear on faces and body languages of two children. Gradually they started mixing with others and becoming free. They never hide their surprise as to why police lifted them from their father's lap. They told that they were taking sweets in a sweet shop along with their father at the time of lifting by police.. They also said that their mother left home after making quarrel with their father and their parental aunt threatened them to keep in a Children Home. The elder boy expressed interest to live with father and the younger one conveyed interest to stay with his mother. Then we made attempt through Child Line Dharmanagar, to make contact with the mother of the children, but no fruitful communication could be yielded over telephonic conversation.

Through functional assessment of both the children, in our Home, it was gradually revealed that the children were bearing no disability at all. Accordingly, we approached Child Welfare Committee, West Tripura District to place those children in Child Care Institution for children having no recognized disability. On 13th September, 2017, Chairperson, Child Welfare Committee ordered transfer of Swapan Sabdakar & Madhu Sabdakar to Specialized Adoption Agency and other Children Home respectively. Madhu & Swapan were placed to respective Home on 20.09.17 & 06.10.17 respectively. By this way two brothers were detached from each others. Disintegration of family touched the culmination point.

Soon after their placement to their respective new Home, Smt. Minakshi Sabdakar, mother of the children, reached to our office and counselling was done to her regarding restoration of two children to their family. With the help of Abhoy Mission, the mother traced her children. According to our suggestion she approached Child Welfare Committee, Dhalai District to get back her children. CWC, Dhalai issued an order keeping in line with her application. Both the children are staying with their mother at Dharmanagr.

# Programs for different sections of community in association with the National Institutes for the Empowerment of Persons with Intellectual Disabilities

### Training Program for Anganwadi workers & Supervisors

National Institute for Empowerment of Persons with Intellectual Disabilities, Secunderabad in cooperation with Abhoy Mission and Department of Social Welfare and Social Education, Govt. of Tripura, organized a Training program on Disability Rehabilitation for Anganwadi workers and Supervisors of Khowai Districts in Old Town Hall of Khowai on 11<sup>th</sup> September,2017. In total, 99 Anganwadi workers and Supervisors participated in the training program.

### **Training Program for SSA Teachers**

National institute for Empowerment of Persons with Intellectual disabilities, under Department for Empowerment of Persons with Disabilities, in cooperation with Abhoy mission and Department of Social Welfare & Social Education, Govt. of Tripura arranged a Training program on Disability Rehabilitation for SSA Teachers in Old Town Hall Khowai on 12<sup>th</sup> September, 2017. In total 100 teachers participated in the program.

# Assessment & Identification Camp for children with disabilities having intellectual disabilities

With objective of facilitation of learning and distribution of Educational Kits, National institute for Empowerment of Persons with Intellectual disabilities, through cooperation from Abhoy Mission and Department of Social Welfare & Social Education, Govt. of Tripura, organized an Assessment & Identification Camp for Children with Disabilities having intellectual disabilities in Old Town Hall Khowai on 14<sup>th</sup> September, 2017. In total, 46 children with special needs and their parents attended the camp.

# State Nodal Agency Centre (SNAC), Tripura State

National Trust assigned responsibility to Abhoy Mission to work as State Nodal Agency Centre (SNAC) in Tripura State. As a part of convergence programme with the Government of Tripura initiative was taken to form State Level Coordination

Committee (SLCC) in the State under the guideline of National Trust. As a result of effort of the organization, SLCC was constituted on 26<sup>th</sup> November, 2014. In Tripura there are Local Level Committees (LLC) in 4 (four) Districts out of total 8 (eight) Districts. With initiative of SNAC-Tripura formation of LLCs in rest 4 (four) districts is under progress

# **Meeting of NGOs**

Meeting of Non Government Organisations (NGOs), convened by State Nodal Agency Centre, Tripura was organized in Abhoy Mission on 26<sup>th</sup> August, 2017. Seven organisations namely Voluntary Health Association of Tripura, Samadrita Society for Disable, Dristihin Unnayan Samiti, Abhoy Mission, All Tripura Blind Committee, Navayoga Uttaran & Pratibandhi Kalyan Samiti participated in the meeting. The meeting adopted resolution that the organisations will register their name under National Trust and in first step apply for registration under Persons with Disabilities Act.

# Sensitization and Awareness program in Sepahijala District

SNAC, Tripura with cooperation from a team of Doctors of Agartala Govt. Medical College organized an awareness program and medical camp for persons with disabilities in Gakulnagar, Sepahijala District on 25<sup>th</sup> November, 2017.

# Community Sensitization and Awareness raising programs in Sepahijala District

On 14<sup>th</sup> January, 2018, SNAC, Tripura organized Community Awareness programme on different aspects of disabilities under the purview of National Trust Act in Gakulnagar Gram Panchayat under Sepahijala District.

# Awareness Programme for school students of different schools

On 28<sup>th</sup> December, 2017, with cooperation from NSS unit of Badharghat H.S.(+2) School, Agartala, SNAC, Tripura arranged awareness programme for school students on holistic development of children with autism, cerebral palsy, mental retardation and multiple disabilities.

On 17<sup>th</sup> January, 2018, through support from NSS unit of Purba Gakulnagar H.S.(+2) School of Bishalgarh R.D. Block , SNAC, Tripura harmonized an awareness programme for school students on difficulties of children with disabilities within the scope of National Trust Act,1999.

### Meeting of Local Level Committee of Dhalai District under National Trust

A meeting of Local Level Committee of Dhalai District under National Trust was held in the office chamber of Addl. District Magistrate and Collector on 31<sup>st</sup> October, 2017. Besides Addl. DM & Collector, Member Secretary, DDRC, Dhalai, CMO & DHO Dhalai District, DISE, Dhalai, Tripura, delegate from DEO, Dhalai District, Jr. SEO, Ambassa, Dhalai, President TPAM, Dhalai were present in the meeting. The meeting decided to update the existing Accounts Book of LLC, Dhalai and requisition will be given for an amount of Rs.10, 000/- only for office expenses of LLC, Dhalai. It was also decided that Annexure-II and Annexure-III will be signed by the concerned opted Member and that will be forwarded to the National Trust, new Delhi.

### Meeting of Local level Committee of West Tripura District

A meeting of Local Level Committee was held in the chamber of Project Director, DRDA, West Tripura District on 9<sup>th</sup> November, 2017. Sri T.K.Das, Project Director, DRDA, Dr. Gautam Debnath, CMO, West Tripura District, Sri Sanjit Rupini, Dy. Director Senior Deputy Magistrate, D.M.'s office, Sri Shyamal Deb, President, Abhoy Mission were present in the meeting. After discussions following decisions were taken-

- It was decided in the meeting that the updating of the activities of West Tripura District Local LLC on web portal of the National Trust through new Scheme Management System
- 2. It was decided to update information of Abhoy Mission and name of Sri Subrata Ganguly will be included as NGO member and person with disability respectively.





With objective to develop positive attitude towards the abilities of persons with disabilities, SNAC, Tripura with support & guidance of National Trust organized a 'One Day Parent Training Program' involving the parents of persons with autism, cerebral palsy, mental retardation and multiple disabilities in Matangini - Pritilata Conference Hall, Agartala. Dr. A. Ranganath, Registrar, ICFAI University, Tripura & Smt. Manidipa Debbarma, Principal, Women's College, Agartala graced the chairs in the inaugural session of the program.

### **Counseling**

We, on regular basis, make counseling to parents to provide support to their children according to each child's individual need. Besides, we organize sensitization programmes for parents of children with special needs.

#### School Readiness Programme
